Subscription Fee and Savings Rate	Each month, you will receive credits on your electric utility bill based on the electricity generated and/or stored by the project. Your subscription fee will be automatically taken from the credits you receive on your utility bill. Your subscription fee is equal to 90% of the value of the credits you receive each month.

Project Location and Customer Allocation	We reserve the right to assign you to any eligible project based on available capacity and will notify you by email when you are assigned to a project. We will determine the size of your allocation based on your historical electricity usage over the previous 12 months (or as many months as available) and we may change your allocation over time based on ongoing analysis of your usage data, not to exceed 100% of your estimated usage on an annual basis. We will provide you with written notice once you have been initially assigned to a project, including the project location and DER type.	
Length of Agreement and Renewal	This agreement shall continue indefinitely until terminated in accordance with the provisions of Section 5 of the Agreement, unless we notify you of a shorter term at the time you are notified of your specific project. Regardless of your term length, you may cancel early for any reason with no fees or penalty.	

#### **Early Termination**

There are no early termination fees for this agreement.

In our experience, it could take the utility up to 90 days to process the cancelation. Until we notify you in writing that your cancelation has been processed by the utility, you may continue to receive credits, with the subscription fee automatically taken as described above, for up to 90 days after your request to cancel.

## Estimated Benefits

You will save 10% on the value of community DER credits received on your utility bill (unless we notify you that we have decreased the price, i.e., provided you with greater savings, in which case the estimated bene:its to you will increase).

For clarity, here is how savings get calculated (all numbers are examples):

- Estimated annual electricity/storage cost = \$1000
- Share of the DER project = 0.277% or 10,000 kWh
- Bill credit value = \$0.10 / kWh
- Savings = 10,000 kWh \* \$0.10 / kWh \* 10% = \$100

Actual savings will depend on your typical annual electricity usage, monthly DER production and/or storage which is affected by seasonal variation and the weather among other factors, and the value of community DER credits which changes over time based on rates set by the utility and governmental entities.

This contract does not guarantee a minimum level of system performance, production and/or storage of energy.

# Data Sharing and Privacy Policy

Arcadia will retrieve data from your utility account. As described in Arcadia's General Terms of Service, this information may include personal customer information, utility usage information, utility bill amounts due, service address and any other information from your utility that may be necessary to provide Arcadia's services.
